# **Terms & Conditions**

### **Golf Course Access and Usage:**

Individuals using the golf course must adhere to all posted rules and regulations. Tee times must be booked in advance. Walk-ins are subject to availability. Proper golf etiquette is expected, including maintaining a reasonable pace of play and repairing divots. Paint Creek Country Club reserves the right to close access to the clubhouse, golf course, or pool in the case of a private event, outing, etc. The golf course season will be determined by Paint Creek Country Club; no members will be permitted on the premises when the season is closed.

### **Booking and Cancellation:**

Tee times can be booked online, in person, or by phone. Cancellations or modifications must be made at least 24 hours in advance; Failure to cancel within this time frame will result in the full rate being charged to the member. Repeated violators maybe suspended or terminated at the courses discretion. Tee times must be reserved in advance and are subject to availability. At peak season times, the golf course reserves the right to pair up single players with other golfers at the course's discretion. This policy is implemented to optimize tee time availability and accommodate as many golfers as possible during high-demand periods.

### **Membership Terms:**

Memberships are subject to the terms outlined in the membership agreement. Membership benefits and privileges may be subject to change. Members are required to pay annual membership fees as determined by the club management. Failure to pay membership fees may result in the suspension or termination of membership.

- Guest Privileges: Members may introduce guests to the club, subject to guest fees and rules set by the club management. Members are responsible for the behavior of their guests while on club premises.
- Club Access: Members have access to the golf course, clubhouse, and other club facilities during regular operating hours. The club management reserves the right to restrict access to certain areas or facilities for maintenance or other reasons.
- Any member breaking or damaging or removing any property of the Club (including table decorations) from the Club premises will be asked to pay the cost thereof, or to replace it.
- It is against Club policy, and the Michigan Department of Liquor Control laws, to consume alcohol on the premises not purchased, or authorized by Paint Creek Country Club.
- All memberships are non-transferable or non-refundable, irrespective of usage, duration, or any other circumstance.
- Payment of the membership fee indicates acknowledgment and acceptance of the nonrefundable policy.
- Paint Creek Country Club reserves the right to update or modify the duration of memberships at any time. Changes will be communicated to members in advance.

### **Dress Code:**

Appropriate golf attire is required on the course and in the clubhouse. All golfers are required to wear a collared shirt that is tucked in. No denim, tank tops, tennis shorts, cargo pants/shorts, swimming trunks, cutoffs, workout clothes, halters, short-shorts and short skirts, swimwear (only in pool area), or other attire deemed inappropriate by Paint Creek is allowed.

# **Terms & Conditions**

#### **Inclement Weather:**

The golf course may close or suspend play during inclement weather for the safety of players and staff. Refunds or rain checks may be issued at the discretion of Paint Creek Country Club.

### **Code of Conduct:**

Players are expected to conduct themselves in a respectful manner towards other golfers, staff, and the facility. Any behavior deemed unacceptable by Paint Creek Country Club may result in suspension of play.

### **Liability:**

Golfers assume all risks associated with playing golf at Paint Creek. Paint Creek Country Club is not responsible for any loss, damage, or theft of personal property.

### Photography and Media:

By using the golf course, players grant Paint Creek Country Club the right to use any photos or videos taken for promotional purposes.

## Golf Etiquette/Course Maintenance:

- The Rules and Etiquette as adopted by the U.S.G.A (United States Golf Association) and R&A (Royal and Ancient Golf Club of St. Andrews) shall be the rules of the Club.
- Players must follow instructions from course staff, including those related to course maintenance. Repair any divots, ball marks, and bunkers after use.
- All players must check in from the Proshop
- No food & beverages coolers are permitted on the Golf Course unless supplied by the Club.
- The practice facility is open during normal operating hours as may be posted from time to time in the Pro Shop.

### **Golf Carts:**

- Private cart owners are responsible for all damages to the golf course caused by negligent use;
   must show proof of liability insurance prior to start of season.
- Operation of the Golf cart is at the risk of the Member or his Guest. No one under the age of 16 is permitted to drive carts.
- The Cost of repair to a Golf cart which is damaged by a Member or his Guest will be charged to Member. The liability of the Golf cart including its accessories, accident and / any physical damage during use is to be borne by the operator.
- The Member or Member's Guest using a Golf cart accepts and assumes all responsibility for liability connected with operation of the Golf cart.

### **Changes to Terms and Conditions:**

Paint Creek Country Club reserves the right to update or modify these terms and conditions at any time. Changes will be effective upon posting. By using the facilities at Paint Creek Country Club, players agree to abide by these terms and conditions. Failure to comply may result in suspension of play or other actions deemed appropriate by Paint Creek Country Club.
